## April Luncheon Meeting with Kay Batey

Division Administrator for the Federal Highway Administration's Illinois Division

On April 20th, **Ms. Kay Batey**, FHWA Administrator for Illinois, addressed a group of 40 at Maggiano's Little Italy in River North. Ms. Batey has been Division administrator for FHWA for almost 3 years and in that time has directed a staff of 33 professionals that deliver the Federal Aid Highway Program in Illinois. Ms. Batey gave a fascinating summary of her impressive career which includes 11 years as FHWA Assistant Division Administrator for Alabama, 8 years as the Planning and Project Development Engineer in North Carolina, four years as a Transportation Engineer in the Louisiana Division and several years as an Environmental Engineer for the Maryland Division.

She took the group through the history of the US roadway policy and the significant changes in each federal Highway Act (later Surface Transportation Act) that Congress passed. She also explained some of the frustrating times when political realities resulted in multiple "continuing resolutions" as a band-aid when the political climate was such that compromise between the parties and/or between the chambers of Congress meant that the Act was drawing to an end, and could not be replaced with a multiyear vision for transportation by the time of expiration. She culminated with highlights of the current Act, the FAST Act, which was signed into law by President Obama on December 4, 2015.

The Fixing America's Surface Transportation (FAST) Act is five-year legislation to improve the Nation's surface transportation infrastructure, including our roads, bridges, transit systems, and rail transportation network. The bill reforms and strengthens transportation programs, refocuses on national priorities, provides long-term certainty and more flexibility for states and local governments, streamlines project approval processes, and maintains a strong commitment to safety.

## A Review of the Institute of Transportation Engineers (ITE) Webinar: Integrating Speed Management within the Three Safety Focus Areas: Roadway Departure, Intersections, and Pedestrian and Bicyclist

On May 05, 2016, the Illinois Section of ITE hosted a snack and learn webinar event to learn about experiences on speed management in three focus areas. The four webinar instructors were **Guan Xu** from **Federal highway Administration (FHWA)**, **Richard Retting** from **Sam Schwartz** consulting, **Shauna Hallmark** from **Iowa State University**, and **Michelle Neuner** from **Leidos consulting**. The ITE webinar was held in Rosemont, Illinois. **Christopher B. Burke Engineering, Ltd**., kindly volunteered to offer their conference room for this webinar.


This webinar has four presentation components, which were presented sequentially 1) speeding, safety focus, and speed management, 2) speed management strategies, 3) role of speeding in fatal crashes, and 4) speed management in agency's overall policies.

Speeding was defined as exceeding the posted speed limit or driving too fast for conditions. This safety issue was further explained in the light of three major Emphasis Areas (EAs) - roadway departure, intersection, pedestrian and pedalcyclists. These three EAs account for 90 percent of total traffic fatalities. It is interesting to know that speeding is major contributing factor for 40% of roadway departure fatal crash, 20% intersection fatal crashes, and 8% of pedestrian/ pedalcyclist fatal crashes. To address these major safety concerns, it is important to incorporate the speed management program into roadway engineering and behavioral issue, engineering safety initiatives, and 3-E countermeasures. There are a number of good resources recommended by the FHWA for these speed management strategies as indicated by **Guan Xu**.

The second component of the presentation discussed the state of practice on speed management strategies. **Richard Retting** discussed policies and procedures, safety plans and focus areas, and research publications and guidance. Then, policies and procedures aligned with Manual on Uniform Traffic Control Device (MUTCD) or some national level guidance on speed limit, related signs and markings were highlighted. Arizona, Florida, Massachusetts, Iowa, Delaware, and Pennsylvania are some leading states where MUTCD and its practice is implemented. He presented the safety plan and focus area as reflected in Strategic Highway Safety Plan (SHSP) that was implemented in some states. For example, 15 states included roadway departure, 9 states included intersections, and 7 states included pedestrians into their EA list.

With safety plans and focus areas, 20 states and number of local agencies have developed focused safety actions and implemented plans. Regarding research publications, National Cooperative Highway Research Program (NCHRP) Report 500 - Volume 23: A Guide for Reducing Speeding-related Crashes and other online FHWA documents are resourceful, as he pointed out.

The third component of the presentation was led by Shauna Hallmark, she highlighted speed-related safety issues. Speed related crashes make up 30 percent of total fatal crashes and carry an average societal cost of \$52 billion annually. In this part, a detailed data analysis based on Fatality Analysis Reporting Systems (FARS) was performed to understand the role of speeding in fatal crashes with the characteristics of crash, vehicular, road and environmental factors as well as the socio-demographics of the drivers and occupants involved in roadway departure, intersections, and pedestrian and pedalcyclist fatal crashes. Figure 1 presents the share of three EAs and speeding-related fatal crashes.




Figure 2: Speeding as a Contributing Factor for Three Major Emphasis Areas

Finally, the fourth presentation component by **Michelle Neuner** highlighted the programmatic strategies on policies, procedures, and practices. These programmatic strategies include establishing or enhancing polices, safety plans, and performance measures, educating and improving awareness, collaborating with stakeholders, establishing process for analyzing speeding-related crash data. Figure 2 highlights the importance of speeding as the core of three overlapping EAs where a Venn diagram reflects their relative share in fatal crashes resulting in fatalities. These three EAs account for 90% of total traffic fatalities, where speeding is found to be the major contributing factors for these fatalities. In order to design appropriate countermeasures for these focus areas, strategies need to be tailored to the detailed crash data analysis encompassing road, drivers, environment, vehicle type and crash type.

The presenter pointed out some keys issues and relevant potential strategies for these three EAs. Finally, the presenter concluded with the following key points -

## May Luncheon with Jason Salley: Illinois Route 59 Construction Project

The May 2016 Luncheon consisted of an overview of the Illinois Route 59 Construction Project and a bus tour of the newly constructed diverging diamond interchange. **Jason Salley, IDOT** District 1 Geometrics Unit Head, led the presentation, hosted in collaboration with the City of Naperville.

Over 60 professionals attended the luncheon at the Naperville Municipal Center and filled the tour bus. The presentation covered the history of the project, proposed alternatives, and the selection of the diverging diamond interchange. Attendees heard about the design considerations of DDI's including operations, safety, pedestrian accommodations, and cost. The audience was very interested in Mr. Salley's "lessons learned" while going through the design and construction of this project.

The event concluded with a charter bus tour along the entire project limits. Mr. Salley pointed out various features along Route 59 which had been covered in his presentation. The bus traveled through the diverging diamond interchange several times, allowing participants a firsthand experience of the DDI design and operations. Multiple diverging diamonds are now being proposed in Illinois, making this a topic of interest for many transportation professionals.

## A Review of the ITE Webinar: TRB Webinar: Scalability of Roundabouts

On March 24th, 2016 the Illinois Section of ITE hosted a Lunch and Learn for the TRB webinar: Scalability of Roundabouts with speaker **Brian Walsh** of **WSDOT**. The presentation covered the safety and delay benefits provided by roundabouts over a typical signalized intersection. Following this, there was discussion of the flexibility of the modern day roundabout. There are four main roundabout variations: mini roundabout, compact roundabout, conventional roundabout, and central island mountable. For example, a central island mountable roundabout was implemented where there was constrained right-of-way but a need to circulate large trucks. The small mountable roundabout (82') was implemented for under \$100,000. Brian also noted that curb details are an important design parameter that must not be overlooked. In order to accommodate truck movements a 2" curb should be use and a rolled curb may be used on the central island. The overall message relayed was that roundabouts can be a very desirable intersection alternative if implemented properly.

The Technical Group looks forward to doing more viewings this year. We want to thank all the attendees for participating in the event and **AECOM** who was generous to offer their conference room.

## **Columbus Awarded \$50 Million in USDOT Smart City Challenge**

Columbus, Ohio has won USDOT's Smart City Challenge, nabbing the \$50 million "smart city" prize to develop Columbus into the nation's proving ground for intelligent transportation. The city beat out six other finalists for \$40 million in federal start-up funds and \$10 million from Microsoft co-founder Paul Allen's Vulcan company. Initial plans include developing a smart card and app to cover bus fares and carsharing services and to expand the use of electric vehicles. The city also has about \$90 million in local matching commitments, including \$19 million in public money.

## **Chicago's City Council Approves Ride-Share Regulations**

Chicago's City Council has approved a water-downed ordinance Wednesday to regulate the rideshare industry in the city. Companies such as Uber and Lyft will now be required to get a transportation network driver license and will be required to continue administering criminal background checks. The issue of fingerprinting has been stalled for the time being. Instead, a six-month study on fingerprinting drivers for background checks for rideshare companies will be conducted.




